HAPPY NEW YEAR! I pray each of you and your family had a safe and **Happy Thanksgiving** and a very **Merry Christmas Season**. And I pray each of us will have a safe, enjoyable, healthy and prosperous 2026.



A BRIEF 2025 RECAP: WHAT A YEAR WE HAD!

- We celebrated our 62nd Chapter birthday at our 20 November meeting.
- We started 2025 with 83 members; very sadly we lost 2 [Major Leonard Krolak, USMC (Ret) and Master Sergeant Jerald Rookstool, USA (Ret)]; and added 13 for a net gain of 11 - **most of them younger** – so, we start 2026 with 94 members.
- We continued to meet bi-monthly to enjoy the camaraderie of our members and spouses with excellent luncheons and dinners and superb, interesting guests speakers – including MG Todd McCaffrey, our SC Secretary of Veterans Affairs.
- We completed our transition to a 501(c)19 non-profit, tax-exempt, charitable veterans' organization, organized a Fundraising Committee and a JROTC Scholarship Committee, and began raising funds internally to support our M. J. “Dolly” Cooper Veterans Cemetery, our Richard M. Campbell Veterans Nursing Home, and established a competitive scholarship program to award a stipend to an outstanding graduating high school JROTC student going to college with intent to join an ROTC program and serve our country.
- We established and filled a new Board position for our Piedmont Chapter, the Director for Public Relations and Publicity, to improve local community awareness of who we are, what we do, and why it's important to our communities.
- We outsourced technological help to Spin Nest Marketing and rolled out our new website in November. It does everything we need it to do and is super easy to navigate. **IT IS LIVE!!!!** Check it out - google it at www.moaapiedmontsc.org. - As we closed out 2025, our membership has graciously and generously given about \$37,000. THANK YOU to those of you who have stepped up and done so!!! We have \$5,000 “fenced” to re-landscape the Carillon area at our veterans' cemetery, have given \$2,300 to our veterans' nursing home for the “general fund” that provides needed items for residents whose family, the VA system or healthcare can't provide, and we now have a little over \$30,000 (including interest) in our JROTC Scholarship Fund to award a scholarship this year for the first time in our chapter's history. WELL DONE, PIEDMONT CHAPTER!

SOME OF OUR 2026 GOALS / CHALLENGES:

- **Maintain continuity in our Chapter leadership** - Officers and Board of Directors. Again, I sincerely thank those of you who are serving - you are a very dedicated, accomplished and professional group that I am so proud to serve with.
- **WE NEED A NEW CHAPTER SECRETARY!** – please let me know if you are interested or have a candidate.

- **Increase membership to 100.** That will take all of us. Each member - please bring a MOAA eligible guest to at least 2 of our 6 membership meetings this year.
- Renew and maintain our current members. I want each of our 94 current members to stay with us – we need the support of each of you! And for those of you who are healthy enough to make it, please plan to join us for each of our membership meetings. - Improve / expand our relationships with the Clemson ROTC and our high school JROTC programs.
- **Award our first JROTC scholarship!**
- Expand / increase local awareness of the Piedmont Chapter.



November Meeting Speaker's Recap

Atty Joel Collins:

- Attorney and Educator
- Graduated from Clemson and USC Law School
- Was to "shadow" Harvey Gantt at Clemson.

Harvey Gantt was the first African American student admitted to Clemson (1963). He became an architect and served as mayor of Charlotte. They remain close friends to this day.

- Established the law firm Collins & Lacy in Columbia, SC

- Member of the Judge Advocate General Corps, USA and served in Vietnam
- Adjunct Professor at Clemson and the Honors College at USC
- President of the American Board of Trial Advocates
- Credits his success to hard work, exacting standards and maintaining strong professional relationships. He hopes to focus more on teaching in the coming years.

Atty Collins spoke about "The Oversized Role of South Carolina on the Revolutionary War".

Some key notes of his presentation:

- The leader of the SC Colony drew up a petition to the Crown in London stating, "We do not recognize you as our leader due to the lack of protection for members of the SC Colony. These same sentiments are reflected in the articles drafted by the Continental Congress in 1776.
- 1765 - SC sent 3 Representatives to the Stamp Act Congress in New York to address the tax imposed by England on all paper products.
- Of all the slaves brought from Africa, 65% came through Gadsden's Wharf in South Carolina. The wharf has since been incorporated into the International African American Museum in Charleston, SC
- 1776 – At the Second Continental Congress, South Carolina sent 4 Delegates to help draft the Declaration of Independence. All 4 of these Delegates were formally trained lawyers, more than the number of formally trained lawyers from all the 12 other Colonies combined.
- 29 June 1776 Battle of Sullivan's Island – This was the worst defeat ever for the British Navy.
- The SC State flag is one of the most recognized of all the states...second only to the Lone Star of Texas. The SC flag was designed by Col William Moultrie. He chose blue to represent the uniforms worn by soldiers from SC during the Revolutionary War. The white crescent represents a gorget which was a metal collar worn around the soldiers' necks. The Palmetto tree was added in 1861 to commemorate Col Moultrie's valiant defense of the palmetto log fort on Sullivan's Island.
- He agreed with historian George Bancroft who said "South Carolinians suffered more deaths, dared more and achieved more than the men of any other state" during the Revolutionary War.

SC Legislative Affairs

South Carolina's 2025-2026 session (leading into 2026) has several key veteran bills, including **S. 695** for safeguarding benefits and curbing predatory fees, **S. 754** expanding free state park access to all SC vets, **H. 3943** offering a new income tax credit for disabled vets, and **H. 3453** addressing tuition for veteran's children. These bills aim to protect veterans from scams, ease park access, provide tax relief, and clarify educational benefits, reflecting ongoing state efforts to support service members and their families.

- **South Carolina Safeguarding American Veterans' Benefits Act (S. 695)**: Aims to regulate who can get paid for helping veterans with claims, setting limits on fees and preventing guarantees of benefits, notes [Fast Democracy](#) and LegiScan.
- **Free State Park Access (S. 754)**: Expands the free entry to South Carolina State Parks to *all* resident veterans, not just disabled ones.
- **Disabled Veterans Income Tax Credit (H. 3943)**: Creates a nonrefundable state income tax credit for disabled veterans, tied to their disability rating, up to \$5,000 annually, reports [SC Statehouse](#).
- **Veteran's Children Tuition (H. 3453)**: Modifies free tuition for children of veterans, potentially requiring residency since birth for qualification, according to the [SC Statehouse](#) and [SC Department of Veterans' Affairs](#).
- **Veterans' Homes Criteria (H. 4385)**: Directs the SC Department of Veterans' Affairs to establish admission/discharge criteria for Veterans' Homes.

What to watch – Next Steps in the Session

- **H.3453** is currently in the Senate Education Committee - that's where final action will matter for tuition assistance expansion.

Many of the bills listed by SCDVA as “of interest” still lack strong momentum, whether they move forward at all may depend on committee interest, budget priorities, and public advocacy.

Even for passed bills (like S.218 or H.3563) - implementation will matter. For example, how DVA sets admissions/discharge criteria for veterans' homes will directly impact veterans.

Military News

Troops to get 3.8% pay raise under proposed defense bill

U.S. service members will receive a 3.8% pay increase beginning Jan. 1 under the final version of the annual defense bill announced by the House and Senate. The proposed fiscal 2026 National Defense Authorization Act makes several changes to Defense Department personnel policy, including a 3.8% across-the-board military pay raise consistent with the Trump administration's proposed budget request, as well as personnel policy alterations designed to improve troops' quality of life.

The proposed legislation authorizes \$900.6 billion for the department, more than \$8 billion over the president's budget request. While the bill authorizes the higher amount, congressional appropriators, who dictate the actual funding, will determine the legislation's final top-line, which could shift as a result. However, defense appropriators have signaled that they will protect the 3.8% pay raise proposed by Trump. The increase means that an E-4 with four years of service would see a boost in base pay of roughly \$134 a month.

Piedmont Chapter – Surviving Spouse Corner

I have been a surviving spouse for 24 years. My husband, a 33-year veteran of the Marine Corps and a naval aviator, died in 2001 from heart disease. He was never a member of MOAA.

I became acquainted with MOAA in 2019 during a visit to Washington, D.C. It was a chance meeting during [Advocacy in Action](#), at which time some in the group learned I was the widow of a Marine Corps officer. I was led to the registration booth and immediately became a MOAA member. I learned there are approximately 47,000 surviving spouse members of MOAA — representing about 12% of the association's members. I'm now a proud Life member.

This brief encounter started a journey for me to be as active as possible. I became my local chapter's surviving spouse liaison and then a member of the Surviving Spouse Advisory Council (SSAC).

Through my involvement with MOAA, I learned about [VA Dependency and Indemnity Compensation \(DIC\)](#). As my husband served in Vietnam and was exposed to Agent Orange, it was determined his exposure subsequently caused the heart disease that contributed to his death. This qualified me to receive this benefit. With the help of a local veterans service officer (VSO) and the [VA Office of Survivor Assistance](#), I will receive this tax-free monthly compensation for the rest of my life.

If you are the surviving spouse, child, or parent of a servicemember who died in the line of duty, or the survivor of a veteran who died from a service-related injury or illness. You might be eligible to receive this tax-free monetary benefit. [Visit the VA's website to learn more.](#)

For additional information and support, contact a local VSO if one is available in your community. Not all VSOs are as helpful as others, but I finally found mine.

To prepare for opening a VA claim for disability or other benefits compensation, applicants must possess the following documents:

Military discharge (DD Form 214) original or certified copy is best for military service information (branch, dates of service, Reserve or National Guard service dates, etc.)

Medical records (military and/or civilian) if available, and if applying for a service-connected disability, contact information for civilian medical providers who treated the veteran for military-related illnesses or injuries (i.e., doctors, specialists, hospitals, etc.)

Bank deposit information (i.e., voided check) — the VA will automatically deposit into this account if benefits are awarded.

If the above documents are not available, veterans or surviving kin can request them online at www.archives.gov/veterans.
